INSTRUCTIONS FOR SUBMISSION

- (1) Two-Bid System: Tender must be submitted in two parts: The Technical bid and financial bid must be given in separately with clear remarks of "TECHNICAL BID/FINANCIAL BID".
 - A. <u>Technical Bid</u>: Details such as compliance with technical specifications, quality certifications, and company experience, company turnover, authorization certificate etc as per Annexure. <u>Hard copy of Technical bid must be submitted physically on or before time deadline to Central office of the Gujarat Vidyapith Ahmedabad by register post/ By hand. Hard copy of the tender should also contain original copy of Tender documents duly signed and stamped in token of having read and understood all terms and conditions and implications thereof.</u>
 - Printed copies & soft copy of the catalogue/price list of the products all kind of standard chemicals, media, Glasswares, Plasticwares and Labwares and Other Laboratory Miscellaneous may also be enclosed.
 - You are also requested to attach the list of institutions/reputed companies in which you have supplied that kind of consumables. (list of your customers).
 - You must have to write that which kind of materials (supply) you are going to provide (Tick mark in Technical bid).
 - B. <u>Financial Bid</u>: Price quotations for each brand item (percentage discount on given branded materials), as per given in the table (Annexure- X) only.
 - The interested tenderer must give their discount rate through E-tendering Website www.nprocure.com only. Special discount/ prices, if any, applicable to the Research Institutions aided by the Govt. of India should be quoted in Annexure -X (Financial Bid)
 - The financial bid of only those bidders who successfully qualify in technical criteria, under technical bid will be opened. Qualified bidder with highest discount rate on current pricelist of mentioned branded products (Annexure-IX & X) will be considered for further procurements of goods.

- The Financial Bid will be evaluated on Item wise discount as quoted in financial bid.
- Gujarat Vidyapith is exempted from paying Excise Duty on procurement of store vide Government Notification No-51/96 customs dated 23 July 1996 and Central Excise dated 01 March,1997 as amended from time to time. However, taxes as applicable may be quoted.
- Rate contract tender can be rejected/cancelled by the undersigned at any time without assigning any reasons thereof.
- Tender document received late/incomplete without requisite papers and Demand Draft for EMD shall be summarily rejected.
- (2) Validity of Rate Contract: The Rate Contract shall be valid for a period of one year and can be extended if, it is mutually discussed/ decided by the supplier and Gujarat Vidyapith. This stability in pricing is required to ensure budget compliance over the fiscal period.

No tenderer shall withdraw his tender after the tender is opened. If a tenderer does so, such tenderer shall be considered ineligible for future also and the amount of EMD will be forfeited.

(3) Earnest Money Deposit (EMD): Bidders are required to submit an Earnest Money Deposit (EMD) of 14,000.00 Rs. by Demand Draft (DD) in Favor of Registrar, Gujarat Vidyapith, Ahmedabad.

The proof of EMD payment (DD) must be uploaded along with the bid documents in the Technical bid and also need to upload proof in Financial bid on N-procure portal. The EMD will be refunded to unsuccessful bidders after bid finalization or will be adjusted towards **Performance Security Deposit** for the successful bidder. Failure to submit the EMD will result in bid rejection.

- (4) Exemptions for MSEs and Recognized Startups: Bidders who qualify under the Ministry of MSME's MSE Procurement Policy, or are recognized as startups by the Department for Promotion of Industry and Internal Trade (DPIIT), are exempted from the EMD requirement. Proof of eligibility must accompany the tender submission. Such bidder has to pay Performance Security Deposit after eligibility for tender before receiving purchase order.
- (5) Performance Security Deposit (PSD): Upon contract award, the successful bidder may request that the EMD be adjusted towards their Performance Security Deposit. Any additional perfomlance security will be required within seven days upon notification. Non-compliance will lead to EMD forfeiture. Performance Security Deposit is collected @5% amount of estimated purchase order value. Or we may deduct PSD from your invoice payment. Performance Security deposit will be returned to the supplier after the contract has been ended.
- (6) Condition of Supply of Goods: Goods must be supply (F.O.R.) at Faculty of Science [For Two Department (1) Department of Microbiology and (2) Department of Food and Nutrition], Gujarat Vidyapith, Near Income Tax Cross Road, Ashram Road, Ahmedabad. You have to supply the goods (FOR) even the order is given for single pack. Suppliers must ensure adherence to the quality standards prescribed and timely delivery.

The items should be supplied as per requirement placed by the institute from **time** to time (periodic requirements) during the entire contract period. If the tenderer is manufacturer or authorized dealer and the item is the PROPRIETARY item then they should furnish the "PROPERIETARY ITEM CERTIFICATE" along with the quotation/Tender.

Packaging, Delivery Responsibilities, Timeline and Penalties for Delays:

- I. Standard items must be delivered within 30 days of receiving the purchase order.
- II. Any anticipated delay must be reported and gets an approval from Dean, Faculty of Science within 10 days of order receipt, citing justifiable reasons. Failure to adhere to these timelines may result in penalties, including contract cancellation or forfeiture of Performance Security.
- III. Suppliers are responsible for packaging, freight, forwarding, and insurance costs.
- IV. Any loss, damage, or pilferage in transit shall be the supplier's responsibility.
- V. Defective or damaged supplies must be replaced within 10 days at no additional cost.
- VI. All supplies shall be made for Faculty of Science, Gujarat Vidyapith, Near Income tax office, Ashram road, Ahmedabad.
- VII. Late Delivery Penalty: 0.5% per week, up to a maximum of 10% of the order value.
- VIII. Misbranded, technically not qualified items will not be accepted and will be returned to the supplier. If the supplied chemical/media/reagents/labwares are not found proper after their use, they are going to be replaced on your own cost.
 - IX. All supplied materials must meet prescribed pharmacopoeia standards (IP/USP/BP/NIST). A Certificate of Analysis (CoA) for applicable items should accompany each delivery, ensuring compliance with quality norms.
 - X. Transportation of materials must be strictly followed the requisite conditions of transportation like temperature controlled etc., if found improper or not as per standard the materials will be rejected at a time.
- XI. Orders will be placed based on actual requirements, without any minimum value constraints.
- XII. Partial supply will not be accepted.
- XIII. Unsatisfactory supply will result in non-payment.
- XIV. Supplies should be made from the latest production batch with maximum shelf life.

(7) Payment Terms:

- I. No advance payment.
- II. Payment will be released within 30 days via e-payment after satisfactory receipt of all ordered goods; no partial payment of partly supplied materials is processed.
- III. Triplicate bills must be submitted to the Registrar, Gujarat Vidyapith, Ahmedabad, for payment processing.

- IV. Tax invoice will be submitted as per assigned order according to individual laboratories of department.
- V. The Institute adheres to strict quality checks in line with internal standards.
