OFFICE ORDER

Subject: Extension of service of Dr. Dipoooba Devda, Professor in Education, up to 31st December 2025.

In pursuance of Resolution No. 20 of the Executive Council adopted in its meeting held on 6 September 2025, and considering the significance of the institutional work assigned to Prof. Dipoooba Devda, Professor in Education, this order is issued as follows:

2. Prof. Dipoooba Devda is scheduled to retire on 31 October 2025 after attaining the age of 65 years. However, in recognition of her valuable academic and administrative contribution, and keeping in view the important institutional responsibility entrusted to her as Coordinator of the Gram Jivan Padyatra Programme, an extension of her service for a further limited period is approved by the competent authority.
3. Under the Gram Jivan Padyatra Programme, all students and staff members of Gujarat Vidyapith will visit a large number of schools throughout the State of Gujarat, interact with students and teachers, and establish contact with alumni to invite them for the Alumni Meet scheduled on 6 December 2025. Prof. Dipoooba Devda has been assigned to coordinate and oversee this extensive institutional activity of great educational and social importance.
4. Accordingly, the term of service of Prof. Dipoooba Devda is hereby extended from 1 November 2025 to 31 December 2025 (both days inclusive). During this extended period, she shall continue to serve as Professor in Education with present statutory responsibilities and Coordinator, Gram Jivan Padyatra Programme, and shall discharge all duties connected with the successful implementation of the programme and the conduct of the Alumni Meet.
5. During the above period, she shall be paid her basic pay – pension as a fixed honorarium from the Vidyapith Fund. All other service conditions shall remain unchanged. This extension shall automatically cease on the close of working hours of 31 December 2025, without further notice.
