1. Eligibility Criteria

- The bidder shall be a registered firm/agency having valid GST Registration and PAN.
 - The bidder shall have a minimum 03 (three) years of experience in similar Audio-Visual / Sound System works.
 - The bidder must have successfully completed at least 03 (three) similar works during the last 02 (two) years, supported with work orders/completion certificates.
 - The bidder shall submit Earnest Money Deposit (EMD) of Rs. 5,000/- in the form of Demand Draft/Pay Order/Banker’s Cheque drawn in favour of Registrar, Gujarat Vidyapith, Ahmedabad.
 - The bidder shall submit valid proof of identity and address (Aadhaar Card/Voter ID/Driving License, etc.).
 - The bidder shall furnish a declaration that the firm is not blacklisted/debarred by any Government/Semi-Government/Autonomous body & No vigilance/CBI/court case is pending against the firm.

2. Two Bid System & E-Procurement

- This tender shall be processed under a Two Bid System, comprising Technical Bid and Financial Bid.
 - The tender shall be participated through E-Procurement portal only, i.e. N-Procurement Portal.
 - The Technical Bid shall include all eligibility documents, EMD details and duly signed tender documents (including Annexure-A).
 - Micro and Small Enterprises (MSEs) registered under Udyam/NSIC are exempted from submission of EMD, subject to submission of valid registration certificate covering the tendered item/service.
 - Startups recognized by Department for Promotion of Industry and Internal Trade (DPIIT) are exempted from EMD on submission of valid certificate.
 - The Financial Bid shall be submitted online only on the n-procurement portal.
 - No hard copy of Financial Bid shall be accepted under any circumstances.
 - Bidders are required to submit hard copy of Technical Bid documents, as specified in the tender notice, within the stipulated time.
 - Financial Bids of only those bidders shall be opened who qualify in the Technical Bid evaluation

2. Scope of Work

- The work includes design, supply, installation, testing, commissioning, operation, supervision, dismantling, and removal of all audio-visual and sound system equipment after completion of the event.
- The contractor shall provide items such as power amplifiers, microphones (corded/cordless), speakers (PA/column/monitor), sound mixers (analog/digital), LED screens, display systems, cabling, connectors, and other related audio-visual equipment as per requirement.

- All equipment supplied shall be of good quality, branded, safe, and conforming to relevant technical standards.
 - Equipment provided shall be latest, well-maintained, and in excellent working condition. Any defective, outdated, or substandard equipment shall not be accepted.
 - The installation shall be technically sound, safe, properly wired, and approved by the concerned authority before use.
 - The contractor shall ensure that the complete setup is installed, tested and made operational at least 01 day prior to commencement of the event.
 - The contractor shall deploy qualified technician's/sound engineers for operation and monitoring during the entire event.
 - The contractor shall ensure uninterrupted performance and necessary backup equipment shall be kept ready to avoid any disruption.
 - The contractor shall be responsible for safe dismantling and removal of all equipment immediately after completion of the event and restoration of the site to its original condition.
 - All electrical connections shall be properly insulated, earthed, and compliant with safety standards ensuring no hazard to persons or property.

3. Payment Terms

- No advance payment will be made.
 - 100% payment after successful completion and certification of work.
 - Applicable statutory deductions (TDS, GST, etc.) will be made as per rules.
 - No separate payment for transportation/vehicles/materials.
 - The quoted rates shall be inclusive of transportation, labour, loading/unloading, and all incidental charges (excluding GST unless specified).
 - The contractor shall be required to deposit Rs. 50,000/- as Security Deposit on award of Contract, which shall be returned upon completion of ARC Contract.

4. Work Execution Rules

- Trained manpower must be deployed for installation and management.
 - All electrical fittings must be properly insulated & tested by a licensed electrician.
 - Electrical wiring must use ISI-marked materials only.
 - Cables/wires shall be laid in such a manner that they do not obstruct movement or pose any hazard.
 - In case of program of dignitaries, contractors shall sign and provide the necessary documents and accessories as per the government norms.
 - The contractor shall comply with all labour laws, safety regulations, and statutory provisions.
 - Contractor is fully responsible for accidents, fire or damages during the event.
 - Child labour is strictly prohibited.

5. Penalty & Performance

- In case of delay, substandard work, or non-compliance, suitable penalty may be imposed, including deduction from bills.
 - Gujarat Vidyapith reserves the right to withhold payment, cancel work order, or terminate contract in case of unsatisfactory performance
 - Repeated failure may result in forfeiture of Security Deposit and debarment from future tenders.

6. General Conditions & Rights of the Employer

- Gujarat Vidyapith reserves the right to accept/reject any or all tenders without assigning any reason.
 - In case of dispute, the decision of Gujarat Vidyapith shall be final & binding.
 - Submission of false/incomplete information shall lead to rejection of bid and forfeiture of EMD/Security Deposit.
