Terms and Conditions of Tender

Name of the work- Demolition of Sahyog Hostel (Block No.7) at Gujarat Vidyapith, Ahmedabad

1. Scope of Work:

The work includes complete demolition of the Demolition of Sahyog Hostel (Block No.7) at Gujarat Vidyapith, Ahmedabad at Gujarat Vidyapith, Ahmedabad, including dismantling, removal of debris, disposal of waste, and clearing of the site as directed.

2. Quoted Amount (Revenue Clause):

The bidder shall quote the amount payable to Gujarat Vidyapith for carrying out the demolition work. No payment shall be made by Gujarat Vidyapith to the contractor. Bid Validity shall be 90 days from the closing of the date of tender.

3. GST Clause:

The quoted amount shall be **exclusive of GST**. Applicable GST shall be payable by the contractor over and above the quoted amount as per prevailing Government rules. Gujarat Vidyapith reserves the right to only allot the specified block among the locations as specified in the tender.

4. Security Deposit:

The successful bidder shall deposit a Security Deposit of Rs.1,00,000/- within 7 days from the date of issue of work order. The Security Deposit shall be refunded after satisfactory completion of the work and site clearance without interest. In case of failure or breach of conditions, the Security Deposit shall be forfeited.

5. Payment Terms:

The successful bidder shall deposit the quoted amount with applicable GST before commencement of the work. Work shall commence only after full payment and Security Deposit are received.

6. Eligibility Criteria:

The bidder should have experience of executing similar three demolition work during the last three financial years (2023-24, 2024-25, 2025-26).

7. Site Inspection:

The bidder shall inspect the site before submitting the quotation and shall be deemed to have understood the site conditions.

8. Time of Completion:

The work shall be completed within the stipulated time as mentioned in the work order, failing which penalty may be imposed.

9. Safety and Compliance:

The contractor shall ensure all safety measures during demolition and comply with applicable laws, labour regulations, and safety standards.

10. Damage to Property:

Any damage caused to nearby structures, utilities, or property shall be the responsibility of the contractor and shall be rectified at his own cost.

11. Ownership of Scrap:

The dismantled materials/scrap shall be the property of the contractor unless otherwise specified, and shall be removed from the site within the stipulated time.

12. Cleanliness and Disposal:

The contractor shall ensure proper disposal of debris and maintain cleanliness of the site during and after completion of work.

13. Performance & Penalty Clause:

Penalties shall be imposed for deficiencies such as delay, unsafe practices, or improper clearance. Continued non-performance may lead to termination and forfeiture of Security Deposit, in line with General Financial Rules 2017.

14. Termination Clause:

In case of non-performance or breach of contract conditions, the authority may issue a show cause notice and after due process, terminate the contract and forfeit the Security Deposit.

15. Force Majeure:

Neither party shall be liable for failure due to events such as natural disasters, pandemics, or Government restrictions. Contract may be terminated if such conditions persist.

16. Dispute Resolution:

Any dispute shall be resolved amicably, failing which it shall be referred to arbitration under the Arbitration and Conciliation Act, 1996. The venue shall be Ahmedabad.

17. Jurisdiction:

Subject to arbitration, courts at Ahmedabad shall have exclusive jurisdiction.

18. Right to Accept/Reject:

Gujarat Vidyapith reserves the right to accept or reject any or all bids without assigning any reason.
